- 91 Academic and scientific societies


#### Over 300,000 "voices":



**FY 2016 President** \$31.1 billion (+3.3%)

FY 2016 House \$31.2 billion (+3.7%)


FY 2016 Senate \$32.1 billion (+6.6%)





#### **NIH** Issues

- Research priority setting
  - Five-year scientific strategic plan
  - Possible restrictions on certain areas of science
- Reproducibility of research results
- Future of young investigators
- Salary cap
- Fetal tissue





#### 21st Century Cures Act (HR 6)

- Establishes research as a national priority
- Sets goals for increased funding
- Raises expectations and creates a target for advocacy
- Establishes new programs and directions
  - Some are helpful
  - Others may be duplicative, unnecessary, overly prescriptive

Risk of accepting new restrictions without receiving actual funding



#### Major NIH Provisions in HR 6

- Three-year authorization at +\$1.5 B for three years
- NIH Innovation Fund provides \$1.75
   B/year for five years
- Proposes to offset cost of Innovation Fund
- NIH Strategic Plan
- Increased accountability
- Reduced regulatory burden





#### 21st Century Cures Act - Status

- E&C Health Subcommittee passed by voice vote on May 14
- Energy & Commerce Committee passed unanimously (51-0) on May 21
- Full House passed (344-77) on July 11



### Senate HELP Committee: Medical Innovation Initiative

- Led by HELP Chair Lamar Alexander (R-TN), and Senators Richard Burr (R-NC) and Patty Murray (D-WA)
- Alexander plans to release bill later this year
- Goals:
  - Examine current time/cost related to the drug and medical device discovery & development process
  - Determine how to improve public policies to support medical innovation
- Will Senate adopt 21<sup>st</sup> CC funding approach for NIH?
