2015 APD GOLDSMITH LECTURER

William L. Roper, MD, MPH

Health Care In America, Now and The Future

Saturday, September 25, 2015

William L. Roper, MD, MPH, Dean of the School of Medicine and Vice Chancellor for Medical Affairs at the University of North Carolina at Chapel Hill (UNC) and CEO of the UNC Health Care System since 2004. He also is Professor of Health Policy and Management in the School of Public Health, Professor of Pediatrics and of Social Medicine at the School of Medicine at University of North Carolina at Chapel Hill.

From 1997 until 2004, he was Dean of the School of Public Health at University of North Carolina. Before joining UNC in 1997, Dr. Roper was Senior Vice President of Prudential HealthCare. He joined Prudential in 1993 as President of the Prudential Center for Health Care Research.

Before coming to Prudential, Dr. Roper was Director of the Centers for Disease Control and Prevention (CDC), served on the Senior White House staff, and was administrator of the Health Care Financing Administration (responsible for Medicare and Medicaid). Earlier, he was a White House Fellow.

He received his Medical Degree from the University of Alabama, School of Medicine, and his Master of Public Health degree from the University of Alabama at Birmingham School of Public Health. He completed his residency in pediatrics at the University of Colorado Medical Center.



Dr. Roper is a member of the Institute of Medicine of the National Academy of Sciences and serves on the Institute of Medicine Governing Council. Currently, he is Vice Chairman of the Board of the Partnership for Prevention, Vice Chairman of the Board of the National Quality Forum, a Trustee of the Robert Wood Johnson Foundation, a member of the Board of Directors of the University of North Carolina Health Care System, and a member of the President's Commission on White House Fellowships. The author or co-author of more than 70 articles in publications such as the Journal of the American Medical Association and the New England Journal of Medicine, Roper has won numerous distinguished service awards from the U.S. Public Health Service, the Association for Health Services Research, the National Association of Health Data Organizations, Emory University, and the University of Alabama.

As CEO, Vice Chancellor, and Dean, Roper oversees an integrated health care system that includes a top-ranked public medical school and modern hospitals for children, women, neurological and psychiatric patients, and general adult patient care.

ABOUT LOWELL GOLDSMITH

Lowell Goldsmith grew up in Brooklyn, New York, and attended medical school at the State University of New York, Downstate Medical Center. He trained at UCLA for two years in medicine and for two years at NIH, doing clinical and biochemical genetics, and then did his clinical and research training at Massachusetts General Hospital in Boston. After being on faculty at Harvard, he rose to be a professor at Duke Medical School, was a recipient of the Macy Foundation Fellowship Award in Biochemistry, Oxford University,

1978-1979, and then began teaching dermatology at the University of Rochester School of Medicine and Dentistry, where he was the James H. Sterner Professor of Dermatology and eventually Dean. Dr. Goldsmith received his MPH in clinical investigation from Rochester in 2002, and has been at University of North Carolina, Chapel Hill since 2002, and for five years served as Editor of the Journal of Investigative Dermatology. His professional highlights include serving as President of: the American Dermatology Association; Association of Professors of Dermatology; Buffalo-Rochester Dermatology Society; New York State Dermatology Society; and the Society for Investigative Dermatology.

THE ENDOWMENT FUND

The APD Lowell Goldsmith Lectureship will be supported by endowment funds raised by the Friends of Lowell Goldsmith as a joint project of the APD and the Department of Dermatology at the University of North Carolina.

SELECTION PROCESS

The President of the APD and the Program Committee will select the Lowell Goldsmith Lecturer. The selected lecturer

will have a proven record related to the scope of the lecture evidenced by written scholarship and documented accomplishments, including implementing innovative ideas. The lecturer need not be a dermatologist. International candidates (non-US/Canada) can be considered.

LECTURESHIP INFORMATION

The Lowell Goldsmith Lecture is delivered at the Annual Meeting of the APD. It is accompanied by a certificate and honorarium. Travel expenses conforming to APD guidelines will also be covered for lecturers who are not APD members. No more than one lecturer is selected annually, but there is no requirement that the lectureship occur each year. There are no restrictions as to the type of degree or the lecturer's area of expertise.


